A Word from the President 2017 Annual Report

It has been my honor to serve as Chair of the MEA Board of Directors this past year. I want to thank the officers, directors, committees, members and staff for making 2017 such an excellent year. Karen Maine of Karen's Electric will do a great job for you as incoming Chair. It has been a busy year and we have accomplished a number of things.

Workforce Development – the shortage of electricians is real and we are all facing the harsh reality of finding good talent. The work that we are doing at MEA will help the industry for years to come. The Electrical Industry recruitment video was finalized this past year and is available for all to use. Partnerships with community-based organizations have been established, and plans are in the works, resources/information/documents have been made available on the MEA website for members to use and industry prospects to view. The statistics for that future job force outlook can be alarming, but spreading our passion for the industry can tap into undiscovered talent.

Government Action – the 2017 legislative session was quick. Some successes for electrical contractors that MEA supported include (1) building permit fees and surcharges have been reduced by as much as 20%; (2) business property tax on commercial structures was reduced; (3) electrical license fees were lowered; and (4) a \$998 billion capital improvement (bonding) bill did pass, which should mean more opportunities to bid on state and local government electrical work.

The Pathway to Licensure bill did not get heard in the 2017 session. August of 2017, MEA staff underwent a restructure of job roles and reporting lines, which has allowed Michelle Dreier to take on the role as Government



Action liaison. Michelle has been working side by side with MEA lobbyist Bill Strusinski for the past few months doing a lot of legwork to gain support on this bill. It will be heard this session by the Senate and the House prior to Committee deadline.

Website Enhancements – by merging the MEA website with our database back in 2016, the MEA staff has been able to efficiently give us, as members, the information that we need. Using these website enhancements has been beneficial for membership in numerous ways: created the ability to sign up for auto draft for annual dues payments; automated the process of dues billings; organized marketing campaigns and order confirmations. More will be automated in the coming year and engagement tracking will be implemented.

Education Enhancements – the development of curriculum improvements from our Director of Education, Jeff Keljik, has been a high priority. All training was updated to reflect the 2017 Code changes as well as a lot of customized training developed to meet our customers' needs.

These are just a few of the many highlights from the year. One of the biggest accomplishments of the association in 2017 was the financial stability. MEA as a whole ended the year with a significant profit, which was \$36,900 over budgeted projections. This allowed us to move \$60,000 into reserves for financial security and the ability to continue to serve the Electrical Industry for years to come. I want to thank you all for the help and support I have received as your Chair of the MEA Board. See you at the Spring Conference on April 20!

You Need to Know

COMPLIANCE

Affordable Care Act Mandate 2018 Deadlines... Similar to notices issued in prior years, the IRS has issued a notice granting an extension for providing employees a copy of Form 1095-C. In Notice 2018-06, the IRS extended the deadline for giving Form 1095-C to employees from Jan 31, 2018, to Mar 2, 2018. The ACA mandates that all applicable "Large Employers" fill out Form 1095-C for all employees who work full-time hours (130 hours) in at least one calendar month. Employers must distribute Form 1095-C to employees and file the form with the IRS, along with the Form 1094-C. Both the Form 1095-C and 1094-C provide information to the IRS about the health coverage the employer offered to employees. This extension does not apply to filing the forms with the IRS. Employers have until Feb 28 (if filing by paper) or Apr 2 (if filing online) to submit Forms 1094-C and 1095-C to the IRS. Employers may request a 30-day extension with Form 8809. Battle over Pre-emption is Back at the MN Capitol... Pre-emption became a top priority in 2017 for Republican legislative majorities in Minnesota and in other states across the nation. On the first day of the 2018 legislative session in Minnesota, lawmakers reinstated a committee, which included members of both the House and Senate, to discuss House File No. 600. In doing so, the most contentious debate of the last session was quietly renewed: whether to pre-empt local governments from setting their own wage and labor rules and other policies.
