COMPLIANCE

New 2020 NEC Enforcement... On April 5, DLI will begin enforcing the 250-volt GFCI receptacle and outlet requirements found in NEC 210.8(A) and 210.8(F). Industry circuit breaker manufacturers have confirmed that supply-chain challenges will be resolved in March 2021. Electrical work authorized by permits issued on or after April 5 must comply with the 2020 NEC. (MN DLI)

New 2020 NEC Errata & TIA... A new errata and TIA tracking document for the 2020 NEC is available at www.dli.mn.gov/business/electrical-contractors/electrical-codes-and-standards. In addition, a list of 2020 NEC FAQs is available and periodically updated.

OSHA 300 log... Employers must complete an incident report (Form 301) for each injury or illness and log work-related incidents on OSHA Form 300. Form 300A must be posted in the worksite from Feb. 1 to **April 30** each year.

2020 NEC... Effective April 1, 2021, the 2020 NEC will go into effect. (DPS.Iowa.gov. March 2021)

NORTH DAKOTA

Licensing Deadline... Master / Class B licenses expire on April 30, 2021. (NDSEB.com)

SOUTH DAKOTA

Licensing Exams & 2020 NEC... Licensing examinations are currently on the 2017 NEC. The Commission is not able to update the exam to the 2020 NEC at this time due to COVID 19. At this time, the estimated date to start examining on the 2020 NEC is July 1, 2021.


