Politics in 2020/2021

We all know how important this year is for our country and our

state. All MN House and Senate seats will be up for election or re-election on November 3. This means that donating to the Electrical Association PAC is more important than ever so our lobbying team can attend fundraisers and develop relationships for a 2021 session that will be distanced, at least in part. This will allow them to maintain current relationships as well as meet legislators coming in. Minnesota is currently the only state with a divided legislator in the House and Senate. This most likely won't remain the same anymore come November, Republicans are losing ground. Your vote makes a difference.

Bonding was supposed to happen this year. It has been a victim of what is happening politically and socially. Minnesota entered 2020 with a \$1.5 billion surplus. The pandemic hit and that flipped to a \$2 billion deficit. The Senate asked for a financial forecast in August for planning purposes and it was not provided. We may be looking at an \$8 to \$10 billion deficit that the legislature will need to correct in 2021.

It is unlikely that a legislator will come to your door this fall. If one does call you, perhaps you can ask them how they would handle a \$10 billion deficit. That will be the largest task at hand in 2021.

Initially legislators felt that a large bonding proposal wasn't necessary because construction was so strong. Everyone was struggling with a workforce shortage. Then the pandemic hit and massive unemployment occurred. The employment numbers are slowly looking better, but the Building Trades estimates a reduction of hours by 10-22% for 2020. In that case, bonding would be a perfect tool to create work. Interest rates are very low.

Enter material shortages into the mix and that provides bonding another challenge. The \$1.35 billion bonding bill that was tentatively agreed upon earlier this year needs to be reworked. Construction materials are in short supply and their prices have escalated because of that. A two by four that would normally cost \$2.50, now costs \$9.00 according to the MN Lumber Association. Project estimates need to be scratched and adjusted. A bonding bill is a mixture of proposed projects. Some of those projects may need to be eliminated from the bill, or the amount of bonding may have to increase dramatically.

The Electrical Association lobbying team will continue to work for you on issues of interest and concern. Survey results are in from membership.

### **A Few Industry and Association Updates**

# Minnesota 2020 NEC Adoption The adoption process is ongoing. A hearing was held on

August 19 regarding the adoption of the 2020 NEC since organizations contested the adoption and the process used to vet the changes. The administrative law judge hired to evaluate, permitted a 20-day comment period following the hearing and a 5-day rebuttal period, which ended on September 15. The administrative law judge has 30 days from the end of the rebuttal period to issue a report, which will have to be reviewed by the Board of Electricity. There are then several procedural steps that the Board of Electricity must follow as well. At this point in the process, we cannot predict an effective date for the 2020 NEC but wanted to share the progress of the adoption with you. We will keep you informed as more information evolves. Until then, the 2017 code remains in effect and the JW and Master exams continue to be based on 2017 as well.

### **Apprentice Training**

Apprenticeship Training has begun! However, there is still time to sign up and get caught up. All lessons are recorded so apprentices can start from the beginning. Providing this training opportunity shows employees how much you value their future with your company.

### Reminders

- All apprentices in the Electrical Association program will have the opportunity to earn 2 hours of CE credit during the program (no additional charge) to fulfill their registered unlicensed requirement.
- 2. All apprentices need to be registered with the MN DOL in order for their hours to count towards sitting for their Journeyworker exam.

Also, if you are interested in Prevailing Wage work or are currently performing it, we have a Minnesota-State-approved registered apprenticeship program that you can enroll your company in. The 144 Related Technical Instruction (RTI) required for the program would be fulfilled through enrollment in the Apprenticeship Training.

### **MN Business Services Firms Expect Mostly Contracting Conditions Next Year...**

Highlights from the study include the following:

- 52% expect a decline in corporate profits for MN economy, while 28% expect them to remain the same and 20% anticipate an increase
- 64% expect their own business productivity to either stay the same (48%) or increase (16%)
- 81% expect their labor availability to either stay the same (67%) or increase (14%)
- 75% anticipate their employment level to remain unchanged (65%) or increase (10%)
- 49% expect inflation to stay the same, while 46% expect it to go up


