From the Executive Director Invest in Apprentice Training—Classes Start Sept 27

It's time to start thinking about getting your apprentices registered for the 2022-2023 EA Apprenticeship Course. If you can register before July 8, you'll be able to take advantage of the

early-bird rate. I'm going to throw it over to Joe Gatewood, our Education Committee Chair, to cover the benefits and features of our program...

As an electrical contractor myself, I know you're busy with the day-today of running your business. We need an efficient and productive team working for us. If you are lucky enough to have an apprentice or two, it's easy to see that proper training helps you avoid code violations and profit-killing rework on jobs.



The Electrical Association offers a 4-year course for your apprentices. They will dedicate 6 hours a week outside of work to related technical training: 3 hours of online instruction and 3 hours of homework and quizzes. Upon completion of the course and 8,000 hours on-the-job experience, your apprentices will be prepared and eligible to sit for the journeyworker exam.

In addition, we offer a fifth year of "Extended Training" material for students needing or wanting extra instruction. We are currently revising the entire first semester into an 11-week exam prep course. The second semester is also being revised and will cover topics including NFPA 70E safety, solar, swimming pool installation, EV charging stations, gas stations, generator installations, transformer installations, low voltage, medium voltage, basic troubleshooting theories, real troubleshooting, and general equipment troubleshooting.

If you already have your apprentices enrolled in EA's Apprenticeship Course, THANK YOU for trusting us with your education dollars. If you haven't committed yet, here are some good reasons that put our program above the others:

- Federally Approved for 144 hours of Related Technical Instruction (required for any registered apprenticeship programs)
